### GAMEQUEST

#### ELIGIBILITY REQUIREMENTS, APPLICATION RELEASE AND WAIVER

- 1) You must be at least 18 years of age.
- 2) You must be a legal US resident.
- 3) You must have a passport that will be valid for travel to Germany in early November 2008.
- 4) You must not be a candidate for public office and must agree not to become one until after one (1) year after the initial broadcast of the episodes of the Program in which you appear, if selected as a participant.
- 5) You may not participate in the Program if your participation would create impropriety or the appearance of impropriety. In making this determination, Quay Street Enterprises Inc. ("Producer") will consider whether you or any member of your immediate family or anyone living in your household is or has been within the last two (2) years an employee, officer, director or agent of any of the following:
  - (a) Any television production company, network, station or distributor that exhibits or distributes the show;

- (b) Producer, or any other person or entity any person or entity involved in the development, production, distribution or other exploitation of the reality-based program currently entitled "WCG GameQuest" (the "Program") or any variation thereof;
- (c) Any sponsor of the Program or its advertising agency; or
- (d) Any person or entity supplying prizes or other services to the Program.

In addition, Producer reserves the right to render ineligible any person whom any of them determines, in its sole discretion, is sufficiently connected with the production, administration, judging, or distribution of the Program, such that his or her participation in the Program could create the appearance of impropriety.

- 6) If selected as a participant you must execute waivers and release agreements required by Producer or any of its licensees, successors or assigns.
- 7) You will need to be available to the production on or about September 24, 2008 for finalist call backs and on or about October 12, 2008 to start production of the Program and be willing to travel to various locations as part of production. Dates subject to change at any time.
- 8) Any offer to become a participant is conditioned upon your submission to physical and psychological examinations to be conducted in Los Angeles, CA, by medical professionals selected by and paid for by the Producers and the certification of the medical professionals that you meet all physical and psychological requirements. - 9) You hereby give the following representations, warranties, acknowledgements, consents and releases:

(a) By signing below, I hereby represent, warrant, acknowledge, and agree that: (i) I have read and I meet and agree to be bound by the eligibility requirements; (ii) I have completed this application honestly and accurately; (iii) if any of the information in this application is found to be false or incomplete, this will be grounds for dismissal from the Program participant selection process, and/or from the Program contest (if any), if selected; (iv) even if I meet the eligibility requirements, Producer has no obligation to interview me, and/or select me as a participant; (v) even if I am selected as a participant, Producer has no obligation to conduct the Program contest (if any) or produce the Program it may not be broadcast or exhibited, even if produced; (vi) all decisions by Producer concerning selection of the participants are final and not subject to challenge or appeal; and (vii) Producer has no obligation to return any materials submitted by me as part of the application whether or not I am selected as a participant.
